

Privacy Policy and Your Privacy Rights

Revised: August 2017

Web site privacy policy for TCE.

This policy applies only to the websites and not to other services offered by TCE or other methods of collecting data. We are committed to protecting your privacy. The policy explains how your personal information is secured and utilized to get you the requested information only. By visiting the site and submitting your personal information you are accepting the terms of the Privacy Policy.

Collection of Information

When you submit a request for information you have the option of how much information to submit. This is done voluntarily by the sender. Personal information that can be submitted is names, postal addresses, email address, and phone numbers. Most information is submitted as a request to be contacted and in order to do so we need a means of contact. You may limit what you submit to just one method mentioned (i.e. name with email only or name with only a phone number). We do not knowingly collect information on minors under the age of 13. If we learn that a person under 13 has submitted personal information it will be immediately deleted from our database.

Automated Information

Currently we do not use automated collections or install "cookies" into your hard drive. Any information we collect must be submitted by the sender requesting information.

The Use Of Your Information

The information collected, as submitted by the sender, is used in the following ways:

- For the purpose you specifically provided the information for. (i.e. class schedule, or tuition)
- Contact you about any accounts or transaction you have with us and products you have shown an interest about.
- Send updates on classes, schedules, products, services and special events.
- We use it to analyze the websites and make any changes as needed.

Sharing with Third Parties

Currently, we do not share information with third parties. We may however add your information to our newsletter recipient list. However, when you receive a newsletter or other announcement, you have the option to "opt out" and discontinue receiving future emailing.

The Ability to Choose

At no cost to you, just call or email us requesting to unsubscribe or in your own words to be taken off our database.
